4.1. General First Aid Information

4.2. Most Important Symptoms and Effects, Acute and Delayed

Causes severe skin burns and eye damage. Causes serious eye damage. Mildly corrosive liquid. May be fatal if swallowed. May cause irritation to all areas of contact. Harmful if inhaled. Inhalation may cause lung and tooth damage. Immediately wash areas of contact with plenty of water for at least 15 minutes. If ingested, give large quantity of water. Do not induce vomiting. **EYE CONTACT:** Eye contact may cause severe eye damage followed by loss of sight. Vapor exposure may cause watering and irritation to eyes. **SKIN CONTACT:** May cause irritation, redness, and pain. **CHRONIC EFFECTS / CARCINOGENICITY:** Repeated exposures may cause erosion of exposed front teeth, darkening of skin and chronic inflammation of the nose, throat and bronchial tubes.

4.3. Medical Attention or Special Treatment Needed

5.2. Specific Hazards Arising from the Substance or Mixture

Above flash point, vapor-air mixtures are explosive within flammable limits noted above. Contact with strong oxidizers may cause fire. 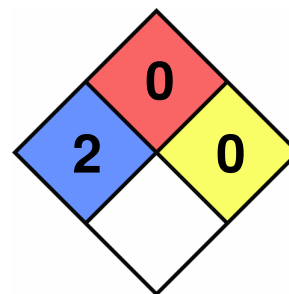
