### 4.1. General First Aid Information

### 4.2. Most Important Symptoms and Effects, Acute and Delayed

Irritation and burn effects may be delayed. If swallowed, give large quantity of water or milk. Do not induce vomiting. Vomiting may occur spontaneously. Call a physician immediately. If breathing is difficult, give oxygen. Wipe off any excess material from skin and then immediately flush with plenty of soap and water for at least 15 minutes. Apply bandages soaked in Magnesium Sulfate. Administer with milk, chewable calcium carbonate tablets or milk of magnesia. Vomiting may occur spontaneously. Do not induce. Call a physician immediately.


