4.1. General First Aid Information

Eye Contact: IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Eye contact may cause severe eye damage followed by loss of sight. Vapor exposure may cause watering and irritation to eyes.

4.2. Most Important Symptoms and Effects, Acute and Delayed

Causes severe skin burns and eye damage. Causes serious eye damage. Toxic if inhaled. Danger! Corrosive liquid. May be fatal if swallowed. Causes severe burns to all areas of contact. Harmful if inhaled. Inhalation may cause lung and tooth damage. Immediately wash areas of contact with plenty of water for at least 15 minutes. If ingested, give large quantity of water. Do not induce vomiting. The Ammonium Hydroxide used to manufacture this product is completely converted to Ammonium Acetate during the manufacturing process. EYE CONTACT: Eye contact may cause severe eye damage followed by loss of sight. Vapor exposure may cause watering and irritation to eyes. SKIN CONTACT: May cause serious damage to the skin. Effects may include redness, pain, skin burns. CHRONIC EFFECTS / CARCINOGENICITY: Repeated exposures may cause erosion of exposed front teeth, darkening of skin and chronic inflammation of the nose, throat and bronchial tubes.

4.3. Medical Attention or Special Treatment Needed

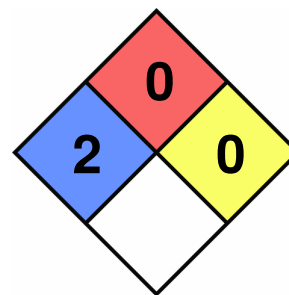
