SECTION 4: First-Aid Measures

4.1. General First Aid Information

If ingested, give large quantity of water and induce vomiting. Call a physician. Contact may cause dryness and cracking of the skin. May cause irritation to the eyes. Wash areas of contact with plenty of water. May cause irritation of the respiratory system. Reagent Alcohol consists of 90% Ethanol, 5% Methanol and 5% Isopropanol. The hazards listed on this SDS are primarily due to the Ethanol. EYE CONTACT: May cause irritation with burning and stinging with possible damage to the cornea and conjunctiva. SKIN CONTACT: Results in drying and cracking which can lead to secondary infections and dermatitis. Dermal absorption causes many of the symptoms of inhalation.

4.3. Medical Attention or Special Treatment Needed


