Treat the solid residue as normal refuse unless there are regulations prohibiting this practice due to the iron content. Always dispose of in accordance with local regulations.

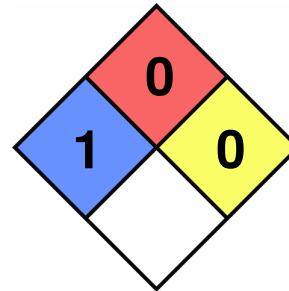
