Serious exposures to Iodine are seldom encountered in industry due to the low volatility of the solid at room temperatures. Wash areas of contact with water. **EYE CONTACT:** Causes irritation. **SKIN CONTACT:** May cause irritation. Will stain skin. **CHRONIC EFFECTS / CARCINOGENICITY:** Chronic ingestion of large amounts may result in thyroid disease.

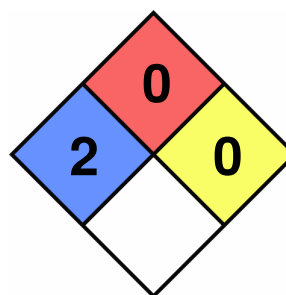
