4.2. Most Important Symptoms and Effects, Acute and Delayed

Most assume that solutions of Silver Nitrate do not reach hazardous concentrations until approximately 5%. Will temporarily discolor skin. Wash areas of contact with water. May be fatal if swallowed. Can cause sore throat, vomiting, and diarrhea. EYE CONTACT: May cause irritation, redness, pain, and tearing. SKIN CONTACT: May cause irritation and temporary discoloration of skin. CHRONIC EFFECTS / CARCINOGENICITY: Chronic exposure can cause permanent bluish discoloration of the skin.

4.3. Medical Attention or Special Treatment Needed

Immediately call a POISON CENTER or physician. Specific treatment (Wash areas of contact with water). Irrigate immediately with large quantity of water for at least 15 minutes. 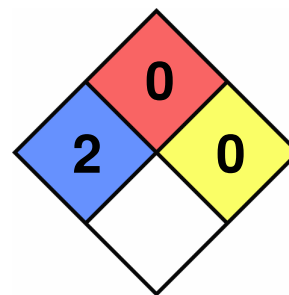
