### SECTION 4: First-Aid Measures

#### 4.1. General First Aid Information

#### 4.2. Most Important Symptoms and Effects, Acute and Delayed

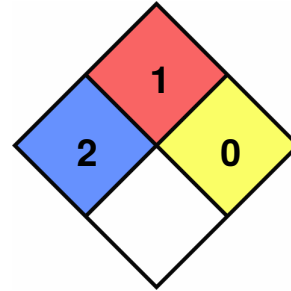
