SECTION 4: First-Aid Measures

4.1. General First Aid Information

Eye Contact: IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. May cause irritation with burning and stinging with possible damage to the cornea and conjunctiva.

Inhalation: IF INHALED: Remove person to fresh air and keep comfortable for breathing.

4.2. Most Important Symptoms and Effects, Acute and Delayed

May be fatal if swallowed and enters airways. Causes serious eye irritation. Harmful if inhaled. DANGER! Extremely flammable liquid and vapor. Keep away from heat, sparks and open flames. May be fatal if swallowed. Avoid breathing vapor. Use with adequate ventilation. Avoid contact with skin, eyes, or clothing. If ingested, do not induce vomiting. 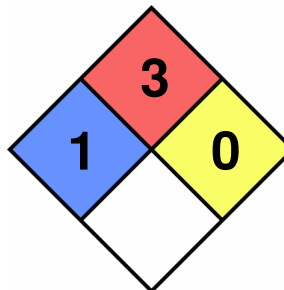
